EU School Milk Scheme Revision: Contributing to children's healthy eating habits

The European Commission is making progress in the revision of the EU School Scheme. In July, we as EDA contributed to the second phase of the European Commission's public consultation of the scheme ([here](#) you can find our position paper on the field).

Next to last April's technical interview with the European Parliament services on the revision of the scheme, last week we shared our arguments and concerns in an interview for a further European Commission's study on the EU School milk scheme.

We underlined that shaping children's healthy eating habits is the core objective of the scheme and that the review of the policy should be focused on reducing the administrative burdens inside the program which complicate and sometimes disincentivize the application to the scheme.

Within the European Parliament's Agri Committee, **MEP Marc Tarabella (S&D, BE)** is in the leading role for this highly important dossier, together with **MEP Salvatore De Meo (EPP, Italy)** and **MEP Sarah Wiener (Greens, AT)**. A great team, since MEP Marc Tarabella has a huge experience in the school food scheme as he was already in charge of the 2017 reform, MEP Sarah Wiener is a highly acknowledged chef who started back in 2007 a foundation 'For healthy children and for good food' (see [here](#), in German only), and MEP Salvatore De Meo (EPP, Italy) is an outstanding expert in all agrifood and dairy topics.

Mandatory Origin Labelling: EU Commission ready to end the Single Market project for EU dairy

"Regarding origin labelling, as announced in the Farm to Fork Strategy, the EU Commission is currently working on a legislative proposal aiming to extend mandatory origin indication to certain food categories, including milk. The impact assessment conducted to support this proposal is expected to be submitted to the Regulatory Scrutiny Board in the coming weeks." This is the EU Commission's technocratic wording in a letter to EDA of 3 August 2022 announcing the end of the Single Market project for EU dairy.

"Despite the more than clear wording of the 2016 legal opinion of the EU Commission Legal Service and the ruling of the European Court of Justice (C-485/18), the EU Commission continues to work on its project to end the Single Market for EU dairy. Now, they base this project on the Green Deal ambitions and the Farm to Fork strategy. It did not come as a surprise to us that the competent services within DG SANTE were not in a position in our July 2022 exchange to cite a single reference nor provide any scientific evidence to substantiate their assumption that mandatory national origin labelling for milk and dairy will help to achieve our common European Green Deal ambitions," claims EDA secretary general Alexander Anton.

Nutri-Score: discriminating our culinary heritage and traditional foods

In light of the recent developments regarding the European Commission's proposal to implement a harmonized front-of-pack nutrition labelling scheme, EDA has taken the initiative to organise a meeting with the competent services of the European Commission to elaborate on the inconsistencies of a colour-graded scheme.

Nutri-Score is an (over-)simplified nutritional information system supposed to help consumers make healthier food choices while basing its negative scoring on calories, saturated fats, sodium and sugar content. As brought forward by the French interbranch organization [CNIEL](#) and a new study by [KU Leuven](#), this system does not take all the nutritional qualities of foods into account and disregards the nutritional value of cheeses, as well as the natural character or the reduced use of additives in traditional products. This inevitably leads to the discrimination of certain products such as cheese and traditional foods protected under geographical indications (GIs), which cannot be "reformulated" and remain not only part of a healthy and balanced diet, but an essential pillar of our European diet and our cultural and culinary heritage.
